Section 4 - First Aid Measures

Suitable extinguishing media: Water fog. Foam. Dry chemical powder. Carbon dioxide (CO₂).

Methods and materials for containment and cleaning up: The product is immiscible with water and will spread on the water surface.

Small Spills: Wipe up with absorbent material (e.g. cloth, fleece). Clean surface thoroughly to remove residual contamination. Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Environmental precautions Avoid discharge into drains, water courses or onto the ground.

Large Spills: Stop the flow of material, if this is without risk. Dike the spilled material, where this is possible. Cover with plastic sheet to prevent spreading. Absorb in vermiculite, dry sand or earth and place into containers. Use clean non-sparking tools to collect absorbed material. Following product recovery, flush area with water.

Section 7 - Handling & Storage

Precautions for safe handling: Do not handle, store or open near an open flame, sources of heat or sources of

ignition. Protect material from direct sunlight. Avoid contact with eyes. Avoid prolonged exposure. Provide adequate ventilation. Wear appropriate personal protective equipment. Observe good industrial hygiene practices. Wash contaminated clothing before reuse.

Conditions for safe storage, including any incompatibilities: Do not handle or store near an open flame, heat or other sources of ignition. Prevent electrostatic charge build-up by using common bonding and grounding techniques. Store in original tightly closed container. Store away from incompatible materials (see Section 10 of the SDS).

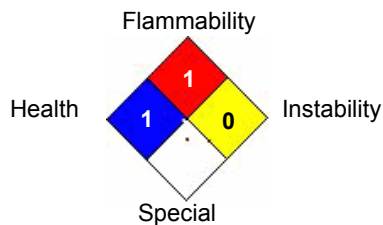
